Section I. NOTICE INVITING TENDER

Bank Note Paper Mill India Private Limited (BNPM) is a joint venture company between Bharatiya Reserve Bank Note Mudran Private Limited (A wholly owned subsidiary of Reserve Bank of India) and Security Printing and Minting Corporation of India Limited (100% owned by Government of India), incorporated for setting up & manufacturing of bank note papers at Mysore.

1. E – Bids are invited by BNPM from eligible & financially sound bidders for Disposal of MEE (MULTI EFFECT EVAPORATOR) SALT as enlisted in Section II of this tender document at BNPM, Mysore – 570003 "As -is -where -is" basis.

- 2. **Eligibility Criteria:** The prospective bidders should submit the documents as mentioned below.

 - Document to be submitted: Valid KSPCB/CPCB/ respective SPCB (in case of disposal involving transboundary movement) authorization for handling Hazardous Waste Category 35.3.
 - c) Bidder should have valid consent of disposal by landfilling of Chemical Sludge from waste water treatment (MEE Salt: Hazardous Waste Category 35.3) from KSPCB /CPCB/ respective SPCB (in case of disposal involving transboundary movement).



Document to be submitted: Valid consent of disposal by landfilling of Chemical Sludge from waste water treatment (MEE Salt: Hazardous Waste Category 35.3) from KSPCB /CPCB/respective SPCB.

- d) Bidder shall be Individual/ firm/ company/ corporate / LLP / HUF / limited company intending to bid should be bonafide, experienced, technically competent, resourceful and financially sound to carry out the assigned order.
 - Documents to be submitted: Company's registration / Certificate of incorporation/Partnership Deed/Any other registration certificate as applicable.
 - All the documents should be duly signed by the authorized person of the bidder. Power of attorney in Rs. 1000 Stamp Paper (For General) or Rs. 500 Stamp Paper (For Special) /Board Resolution/proprietor declaration/Partners confirmation should be submitted for the signing authority from the competent authority of the company.
- e) Bidder should have minimum annual capacity of 180 MT of disposal of MEE salt.
 - Documents to be submitted: Valid consent of KSPCB/ CPCB/respective SPCB mentioning the permitted annual disposal quantity by landfilling of Chemical Sludge from waste water treatment (MEE Salt: Hazardous Waste Category 35.3)
- f) Bidder shall submit following declarations in Letter Head with sign & stamp:
- i. Hazardous wastes of Category 35.3(Chemical Sludge from waste water treatment (MEE Salt) shall be collected from BNPM premises as per the KSPCB/CPCB regulations.
- ii. Loading, transportation, unloading, reprocessing shall be done by the bidder as per hazardous & other waste (Management & transboundary movement) Rule 2016. Any deviations during the process shall be solely attributed to the bidder. Bidder required to abide to the guidelines prescribed by the KSPCB.
- iii. Bidder, without failing, shall obtain **Form 9 (Transport Emergency Card/TREM)** duly filled from the BNPM before the hazardous waste leaving the premises of BNPM.
- iv. The transportation of the MEE Salt (Chemical Sludge from waste water treatment) shall be in accordance with the existing rules and guidelines by the respective pollution control board and in accordance with the rules made by central Govt under motor vehicles act 1984. The transportation vehicle shall have along with it, the **Fitness certificate of the vehicle, valid documents/authorization from KSPCB for the transportation** of the Hazardous waste.
- v. The responsibility of the safe transport of the hazardous waste shall be sole responsible of the receiver and shall have the necessary authorization for the transportation by the concerned state pollution control board. The same shall be clearly indicated in the manifest (Form -10).
- vi. On receipt of the material, Form 10 Hazardous Waste Manifest for disposal of MEE Salt shall be sole responsibility of the receiver and shall have the necessary authorization shall be issued to BNPMIPL. It will be the sole responsibility of bidder to use the material as per CPCB/KSPCB norms.
- vii. In case of transportation of hazardous and other waste (here MEE Salt) for final disposal to a facility existing in a State other than the State where the waste is generated, the sender shall obtain 'No Objection Certificate' from the State Pollution Control Board of both the States.



- viii. Bidder shall maintain records of MEE Salt purchased in a passbook issued by the State Pollution Control Board along with the authorization.
- ix. MEE Salt shall be handed over to the **bidder only after making the entry into the passbook** Issued by KSPCB.
- x. MEE Salt shall be disposed by landfilling method in a dedicated area approved by KSPCB/CPCB.
- 3. Online bids are to be submitted through e tender portal (www.tenderwizard.com/BNP) only.

Note:

Against receipt of the following notification through email from tenderwizard portal, bidder must resubmit the bid even if the bidder have already submitted the bid through tenderwizard portal.

Notification: If you have already submitted the tender, then ensure that you resubmit the tender. Else, your bid may be liable to be auto disqualified by the system. And service provider holds no responsibility for the same. In case, you are yet to submit the tender, then please ensure that you submit it before the tender closing time.

Submission / resubmission of the bid is the responsibility of the bidders only. 4. Bid submission procedure:

Online bids:

Tenders are to be uploaded on e-tendering portal <u>www.tenderwizard.com/BNP</u> only in Two-part bid system.

- i) <u>Part-I Prequalification Bid & Techno-commercial Bid</u>: Registration Fee, Tender Processing Fee, EMD/Bid Security Declaration as per Annexure A is to be submitted (For MSE Bidder), Scanned copy of supporting documents related to eligibility criteria (As mentioned in NIT) along with all sections, annexures of this tender (except Sec IV, Price Schedule, which has to be submitted as mentioned in Sl.No.ii below) duly signed & stamped by authorised person in each & every page. (To be submitted through E-portal only)
- ii) <u>Part II Price Bid</u>: Price Bid shall be submitted through e-portal only, the price bid is liable for rejection if submitted in any other mode. Price Bid should be submitted as per the price bid format provided in Sec –IV, Price Schedule of this tender. **Price Bid submitted in any other format will be liable for rejection. Price bids with conditions / Counter conditions are liable for rejection.**
- 5. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected. In line with evaluation criteria bid may be submitted item/schedule wise.
- 6. **Bid Validity:** The tender shall remain open for acceptance for a period of **120 days** from the date of opening of the tender.

7. **EVALUATION CRITERIA:**

(i) At first stage, techno-commercial bid will be opened and evaluated by the competent committee / authority with reference to the parameters prescribed in the tender document. Subsequently in



the second stage the financial bids of only techno commercially acceptable offer as decided in firs stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable bidders to enable them to attend the financial bid opening, if they so desire.

- (ii) Price evaluation will be based on overall effective L1 price basis i.e total quoted price excluding GST.
- (iii) However, the acceptance of the tender will rest with BNPM, who does not bind himself to accept the lowest tender and reserves the authority to reject any or all of the tenders received without assigning any reason thereof.
- (iv) If multiple bidders quote the same price and become L1 (i.e there is a price tie) then orders will be placed with proportionate tender quantity basis to all the L1 bidders.
- (v) BNPM reserves the right to reject any offer including the lowest one if the same is not conforming to its norms. The decision of BNPM in this regard will be final.

8. **Discrepancy in Prices**:

- If, in the price structure quoted by a tenderer, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless BNPM feels that the tenderer has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.
- 8.2 If, there is an error in a total price, which has been worked out through addition and/or subtraction of subtotals, the subtotals shall prevail and the total corrected; and
- 8.3 If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.
- 8.4 If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the tenderer by registered/speed post/email. If the tenderer does not agree to the observation of BNPM, the tender is liable to be ignored.
- 9. **Earnest Money Deposit (EMD):** Interest free EMD of Rs 1,06,000.00/- (Rupees One Lakh Six Thousand only). The EMD shall be paid through online at e tender portal (www.tenderwizard.com/BNP) or though BG as per the prescribed format provide in the tender. The tender without EMD shall be liable for rejection.

For MSE Bidders:

- a) Submission of EMD is exempted for Micro and Small enterprises (MSEs) as per the Public Procurement Policy for MSEs Order, 2018.
- b) MSEs should be registered and also will continue to remain registered during the tender validity period with District Industries Centre (DIC) or Khadi and Village Industries Commission (KVIC) or Khadi and Industries Board (KVIB) or Coir Board or National Small Industries Commission (NSIC) or Directorate of Handicrafts and Handlooms or UDYAM Registered or Any other body specified by Ministry of MSME.



Note:

- i. Micro and Small Enterprises (MSEs) having major activity as "Manufacturers" and "Service Providers" as per UDYAM certificate are eligible for claiming EMD exemption. EMD exemption can be claimed irrespective of NIC code specified in UDYAM certificate.
- ii. An enterprise re-classified to "Medium" as per UDYAM Certificate may continue to avail EMD exemption from the enterprise type it was in before the re-classification (i.e. Small/Micro), for a period of three years from the date of such re-classification. An enterprise classified continuously as "Medium" beyond three cannot claim EMD exemption.
- iii. MSME's having major activity as "**Trading**" for availing benefits of Priority Sector Lending (PSL) only as per UDYAM certificate are excluded from claiming EMD exemption. Such bidders are required to submit EMD as per tender, else their bid will be considered ineligible/ unresponsive and will be ignored.

For Start-up Bidders:

- 1. Submission of EMD is exempted for Start-up bidders as per the Office Memorandum No. F/20/2/2014-PPD (Pt.) of Ministry of Finance dated 25.07.2017.
- 2. Start-ups should be registered with Department for Promotion of Industry and Internal Trade (DPIIT) Bid Security Declaration as per Annexure-D is to be submitted.

Documents to be submitted:

- i. For MSE Bidders: Valid NSIC / KVIC / KVIB / DIC / UDYAM Registration certificate.
- ii. For Start-ups: Certificate of recognition issued by DPIIT.
- iii. Bid Security Declaration as per Annexure-D is to be submitted by bidders claiming exemption to EMD.

Note: Valid means valid upto Tender/bid validity period.

For Non-MSE/Start-up bidders: EMD is to be submitted, else bid will be rejected.

- 10. **Refund of EMD:** EMD of Unsuccessful bidder will be returned to them without any interest, after expiry of the tender validity period, but not later than thirty days after conclusion of the resultant contract. EMD of successful Bidder will be released on submission of Security Deposit.
- 11. **Security Deposit (SD)**: Within ten days after the issue of notification of award (i.e PO/WO/LOI whichever is earlier) by BNPM, the successful bidder shall furnish performance security to BNPM for an amount equal to ten per cent (10%) of the total value of the contract. Performance security may be furnished in the form of:
 - i. Account payee demand draft
 - ii. Fixed deposit (FDR) from a scheduled commercial bank in India.
 - iii. Unconditional Bank Guarantee issued and confirmed from any scheduled commercial bank with validity up to 60(sixty) days beyond the date of completion of all contractual obligations of the successful bidder, including the warranty obligations.



If the successful bidder fails to resume/complete the work within stipulated time, security deposit of such bidder shall be forfeited. SD shall be interest free. If the successful bidder fails to submit the Security Deposit & does not lift the MEE salt within 2 months of order placement, then BNPM has the right to cancel the order & debar/blacklist that bidder.

12. Payment Terms for Disposal:

Payment will be released within 30 days on proportionate basis from the date of lifting of MEE salt, as per the quantity of MEE Salt lifted and against submission of proper invoice and all relevant document.

Payment will be released vide electronic transfer.

- 13. **Site Visit/ Inspection:** To assess the state/ conditions of MEE salt and to determine the price to be quoted, the Bidder is advised to visit the project site on or before tender submission due date and time and to get acquainted with the conditions at the site.
- 14. **Completion Time & Contract Period:** Work for lifting the available MEE Salt shall be started within 10 working days of issue of Disposal Order and starts lifting of the available MEE Salt and it should be finished within 45 days from the issue of Disposal Order. The MEE Salt available thereafter shall be lifted as and when available for disposal up to period of One Year from issuance of the order. Contract period will be for one year.
- 15. **Liquidated Damage:** If the successful bidder fails to fails to perform the services within the time frame(s) incorporated in the contract and/or as per the schedule provided by BNPM time to time, then BNPM shall, without prejudice to other rights and remedies available to BNPM under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% (Half) percent of the available MEE salt to be disposed off as per the schedule provided for each week of delay or part thereof until actual performance of work, subject to a maximum deduction of 10% of the delayed disposal of each schedule.

16. **Procedure for Disposal of MEE Salt:**

On finalization of tender, a disposal order will be issued to successful bidder by BNPM for the existing available quantity, which has to be completed lifting within 45 days from the date of issue of disposal order. The successful bidder shall intimate BNPM before lifting MEE Salt. Successful Bidder shall arrange vehicle, if any, Tools & tackles /materials required & labour for collection from various places in the site, loading, transportation at his own cost. The safety of the labour will be the responsibility of the bidder. The operation is to be completed within the specified office hours i.e. between 1000 Hrs and 1600 Hrs. No work shall be permitted on Sundays or on closed holidays.

Bidder shall not be allowed to pick and choose the materials. MEE Salt has to be lifted as per the instruction of BNPM only. These material should not be sold to the employees of BNPM. Undertaking this regard has to be provided.

17. Compliance of security Norms:

BNPM is a security organization located in the premises of BRBNMPL and the Govt. of Karnataka declares the premises as Prohibited Area. Hence the contractor has to abide by the security rules of the Company. The contractor has to ensure the character and antecedent of the persons deployed. The contractor must be in a position to produce such documents whenever he is asked to do so. Details shall be furnished as per format when called for. The contractor has to issue printed photo identity card to its workers duly authenticated by the designated security officer of the Company. Contractor should apply for Gate Pass for labours, welding permission and



material entry pass etc. as per approved format only, well in advance to avoid any delay in issue of Gate passes
