<u>Expression of Interest for Supply, Installation, Commissioning of Outdoor Cameras for Peripheral Security of the plant along with enhancing the existing CCTV storage system from 30 days to 90 days in BNPM Plant, Mysuru.</u>

#### 1.0 Objective of work

BNPM invites sealed Expression of Interest (EOI) from the experienced supplier / contractors / resourceful firms / organizations who have proven capabilities in both technical and financial for Supply, Installation and Commissioning of Outdoor Cameras for the Peripheral Security of the plant along with enhancing the existing CCTV storage system from 30 days to 90 days.

#### 2.0 **Preamble:**

The invitation for Expression of Interest is to identify resourceful vendors, Methods and establishing the OFC network, Types of Active and Passive Components requirements, Type of outdoor cameras, enhancement of storage required for CCTV recording by way of providing SAN etc, and to arrive generic specification and estimated cost of the project before calling for competitive bids.

After having the technical details and approximate cost of the total project, the decision to direct adoption shall be taken.

#### 3.0 Scope of Work:

- a) Supplying and Laying of OFC Cables and Power Cables along the Inner Boundary walls of Plant by way of extending the existing CCTV OFC network approximately 7500mtrs.
- b) Supply and installation of required IP Outdoor network cameras at notified locations within the plant premises.
- c) Supply and installation of high resolution cameras having 300-500 meter range at Main and Material gate locations.
- d) Supply and installation of Active and Passive Components required in establishing the Network.
- e) Supply and installation of additional required hardware in the CCTV Server Room.
- f) Assessment of existing Video Management System and Server Handling capacity for adding 40 additional cameras in addition to the existing 206 installed



- cameras (Indoor, outdoor, IR & HD cameras).
- g) Enhancement of storage capacity from 30 days (existing) to 90 days recording for with required FPS and resolution by way of providing SAN or any other system.
- h) Supply and installation of any other active and passive components, network devices, cables etc required in establishing the project.

The applicant should be either proprietary firm/LLP/company/Partnership/ (legal entity) registered under relevant regulation of the respective Country. The applicant should be in business of supply, installation & commissioning of outdoor CCTV cameras along with enhancing storage system.

## 2. Experience:

The Tenderer should be in the field of Supplying, Installation & Commissioning of CCTV system along with enhancing cctv storage system having following qualifications,

- a) Shall be in business in above field for at least Five years, as on 31/12/2018
- b) Shall have record of executed such similar projects.
- c) Shall have ISO 9001:2015 certification.
