## I. NOTICE INVITING TENDER

Bank Note Paper Mill India Private Limited (BNPM) is a joint venture company between Bharatiya Reserve Bank Note Mudran Private Limited (A wholly owned subsidiary of Reserve Bank of India) and Security Printing and Minting Corporation of India Limited (100% owned by Government of India)

1. Sealed tenders are invited by BNPM from eligible & financially sound bidders for Supply of Poly Aluminum Chloride for its BNPM office at Note Mudran Nagar, Mysore - 570003.
2. **Eligibility Criteria:** The prospective bidders should have the following eligibility criteria and should submit the documents as mentioned below.
  - Proof of registration i.e., valid GST and PAN.
  - Not blacklisted/ debarred by BNPM/ Bharatiya Reserve Bank Note Mudran (P) Limited (BRBNMPL) / Security Printing & Minting Corporation of India Limited (SPMCIL) or any Govt. Departments from participating in tender process. Declaration must be given on company letterhead.
  - Firm should have done at least one work of supply and installation of interactive display unit (loaded with OS and/or Required software and having an additional functionality of images moving as slideshows in regular interval with buttons (forward, play/pause and backward) having control over movement of images.
  - Firms satisfying the above eligibility criteria only may be qualified for price bid opening
3. **Cost of Tender Form:** The cost of tender is **Rs.1000/-** and is nonrefundable. The cost of tender shall be paid by Demand draft payable at Mysore in favour of **Bank Note Paper Mill India Private Limited** payable at **Mysore** should be submitted in the envelope containing Earnest Money Deposit (EMD).

**EMD** of Rs. 4000 shall be paid by Demand draft payable at Mysore in favor of **Bank Note Paper Mill India Private Limited** payable at **Mysore** should be submitted in the envelope which will be refunded on successful supply, installation and submission of warranty certificate
4. Tenders should be addressed to The Assistant General Manager, Bank Note Paper Mill India Private Limited and should be submitted on or before **1430 hrs on Nov 20, 2017** in sealed covers at the office of Bank Note Paper Mill India Private Limited, Administrative office Building, Entry Gate-1, Paper Mill Compound, Note Mudran Nagar, Mysuru - 570 003. Tenders in person may be handed over to DGM. The bid shall be opened at **1500 hrs on Nov 20, 2017** at the above mentioned address.
5. Tenders should be submitted in duplicate marked as original and duplicate in a sealed cover, to the offices of the BNPM, super subscribed %Tender for Procurement of 32 inch signage LED display with interactive option using buttons+. The tender shall be submitted as follows:-

6. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected.
7. Tenderers should quote their prices and rates both in figures and in words. No blank spaces shall be left. All erasures and corrections made while filling up the tender shall be initiated by the tenderer.
8. The tender shall remain open for acceptance for a period of 60 days from the date of opening of the tender.

## **9. SCOPE OF WORK.**

### **A. Specifications of TV**

32 inch LED TV . Sinange type

Wall Mounted in vertical position (functionality)

Preferable brand . Sony/LG/Samsung or other brands subject to approval from BNPM

### **B. Integration**

Physical buttons in the bottom of TV

Minimum three buttons (for example, forward, backward and pause button, in case to control images being scrolled automatically in regular gaps)

- C. The Display should possess all the features available in Signage TVs and in addition to that, it must have all required software and OS and an additional functionality of images moving as slideshows in regular interval with buttons having control over it, on required.
- D. The contents to be loaded using external pen drives and HDD (minimum 1TB)
- E. The internal storage capacity of device must be atleast 2GB
- F. The box with buttons must have USB (mouse and keyboard compatibility) and HDMI ports.
- G. Price should include transportation, handling, mounting with handing over in GO live condition.



**10. EVALUATION CRITERIA:**

(i) The method of evaluation of bidder for awarding the Contract shall be on consolidated grand total offered by the bidder and will be decided taking into consideration of the total offered price for delivery up to BNPM, Mysore.

**11.** Prices quoted should include all royalties, duties, taxes, octroi, entry tax, and any other duties and taxes leviable by the Central and state governments and other statutory bodies. The rates quoted will be treated as all inclusive and no further claims whatsoever will be entertained in this respect. The quoted rates should be FOR Mysore site basis.

**12.** The acceptance of the tender will rest with the Owner, who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason thereof.

**13.** The owner also reserves the right to allot the order partly or wholly to single or different Tenderer.

**14. Discrepancy in Prices:**

i) If, in the price structure quoted by a tenderer, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless BNPM feels that the tenderer has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.

ii) If, there is an error in a total price, which has been worked out through addition and/or subtraction of subtotals, the subtotals shall prevail and the total corrected; and

iii) If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail

iv) If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the tenderer by registered/speed post. If the tenderer does not agree to the observation of BNPM, the tender is liable to be ignored.

**15. Warranty:** Product must possess warranty period of one year

**16. Terms of Payment:**

(i) 95% payment on receipt and delivery and activation of license as per our specifications by the consignee at destination and on production of all required documents by the supplier.

(ii) Performance security of 5% of WO amount to be withheld for a period of One year warranty period from the date of completion of work.

(iii) Performance Security deposit may also be submitted in the form of Bank Guarantee,



valid for the period of one year and with claim period of two months thereafter.

Payments to suppliers shall be made by account payee cheque or through ECS only.

17. **Delivery Period:** Delivery shall be made within 30 days of issuing of Work order.
18. **Delivery Terms:** It is responsible of the supplier to arrange transportation and supply the material on FOR destination basis. BNPMIPL requires material on FOR Mysore site office, Note Mudran Nagar, Mysore basis only.
17. **Delay or Non Delivery:** Time is essence of the contract and completion of delivery dates agreed to are binding on the seller. In the event the seller is not able to supply as per the delivery schedules given by BNPM, Purchaser will have right either to cancel the order without prejudice to any other rights or to make purchase from an alternate source at the risk and cost of the seller.

In case of rejection and failure to replace goods, the order will be treated as incomplete and we may cancel the order and will arrange to purchase the goods from elsewhere at your risk and cost and the Work Order / LOI on you will be cancelled and action taken as per the order terms.

18. **Tender Evaluation and award of work:** Tenders will be evaluated as per the terms and based on responsiveness taking into account all relevant factors. While the lowest offer will generally be the criteria, BNPM reserves the right to reject any offer including the lowest one if the same is not conforming to its norms. BNPM reserves the right to accept any Tender and to reject any or all Tenders. BNPM also reserves the right to accept in part or in full any tender or reject any tender without assigning any reason or to cancel the tendering process and reject all tenders at any time prior to award of contract, without incurring any liability, whatsoever to the affected tenderer or tenderers. The decision of BNPM in this regard will be final.
