Section I.
NOTICE INVITING TENDER

1. Bank Note Paper Mill India Private Limited (BNPM) is a joint venture company between Bharatiya Reserve Bank Note Mudran Private Limited (A wholly owned subsidiary of Reserve Bank of India) and Security Printing and Minting Corporation of India Limited (100% owned by Government of India), incorporated for setting up & manufacturing of bank note papers at Mysore.
2. e-Bids may be submitted online (e tender) towards Annual Rate Contract for Sale of Hazardous Waste (Scrap), "As Is; Where Is;" basis at BNPM, Mysore – 570003 by eligible & financially sound bidders.

Online mode of bid submission (e tender):

Tender processing fee is Rs. 1000/- plus applicable Taxes.**

 - d. The NIT along with tender documents will be accessible in the e-Tendering website (viz www.tenderwizard.com/BNP).
 - e. Class III Digital Signature Certificate (DSC) is mandatory to participate in e-Tenders. Participating bidders/Contractors have to make sure that they have the valid DSC. If not, they can procure from any of the RAs approved by CCA.
 - f. Bidders/Contractors should upload and attach all the Scanned copies of technical documents/certificates in e-tendering website www.tenderwizard.com/BNP pertaining to their eligibility criteria mentioned in the NIT, failing which, the bid will not be considered.
- 1. Eligibility Criteria:** The prospective bidders should submit the documents as mentioned below.
- a) Proof of registration i.e., valid GST and PAN.
 - b) For the quoted item/schedule (Ref price bid), the bidder shall have
 - i. Valid KSPCB/ CPCB/respective SPCB (in case of sale involving transboundary movement) authorization for applicable category towards handling the respective hazardous wastes under Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016, issued by gazetted notification vide MOEFCC, GOI on dated 04.04.2016.

- ii. Valid KSPCB/ CPCB/respective SPCB (in case of sale involving transboundary movement) Consent for Disposal / Re-cycling / Re-Processing for applicable category towards handling the respective hazardous wastes under Hazardous and Other Waste (Management and Transboundary Movement) Rules, 2016, issued by gazetted notification vide MOEFCC, GOI on dated 04.04.2016. Hazardous wastes shall be collected from BNPM premises as per the KSPCB/CPCB regulations.
- iii. Aforementioned authorization and consent from KSPCB/ CPCB/respective SPCB (in case of sale involving transboundary movement) should be valid and in force on the date of opening of the tender.

The applicable hazardous waste categories are as follows:

- iv. Valid passbook against corresponding scrap item.

Note: In all above cases validity means valid upto bid validity period.

c) General Criteria: Bidder to submit following declaration:

- i. Bidder shall submit a declaration that they will re-cycle / re-process the scarp as per the rules prescribed in Hazardous & Other Waste (Management & Transboundary Movement) rule.
- ii. Hazardous wastes shall be collected from BNPM premises as per the KSPCB/CPCB regulations.
- iii. Loading, transportation, unloading, reprocessing shall be done by the bidder as per hazardous & other waste (Management & transboundary movement) Rule 2016. Any deviations during the process shall be solely attributed to the bidder. Bidder required to abide to the guidelines prescribed by the KSPCB/CPCB.
- iv. Bidder, without failing, shall obtain **Form 9 (Transport Emergency Card/TREM)** duly filled from the BNPM before the hazardous waste leaving the premises of BNPM.

- v. The transportation of the hazardous waste shall be in accordance with the existing rules and guidelines by the respective pollution control board and in accordance with the rules made by central Govt under motor vehicles act 1984. The transportation vehicle shall have along with it, the **Fitness certificate of the** vehicle, valid documents/authorization from KSPCB/CPCB for the transportation of the Hazardous waste.
- vi. The responsibility of the safe transport of the hazardous waste shall be sole responsible of the receiver and shall have the necessary authorization for the transportation by the concerned state pollution control board. The same shall be clearly indicated in the manifest (Form -10).
- vii. On receipt of the material, Form 10 - Hazardous Waste Manifest for disposal shall be sole responsible of the receiver and shall have the necessary authorization shall be issued to BNPMIPL. It will be the sole responsibility of bidder to use the material as per KSPCB/CPCB norms.
- viii. In case of transportation of hazardous and other waste for final disposal to a facility existing in a State other than the State where the waste is generated, the sender shall obtain **'No Objection Certificate' from the State Pollution Control Board of both the States** with whom the buyer is registered, failing which buyer will be responsible for the consequences and BNPM shall take further action as deemed fit.
- ix. Bidder shall maintain records of hazardous waste purchased in a passbook issued by the State Pollution Control Board along with the authorization.
- x. Hazardous waste shall be handed over to the **bidder only after making the entry into the passbook** Issued by KSPCB/CPCB.

3. Online bids are to be submitted through e tender portal (www.tenderwizard.com/BNP) only.
 Note: Against receipt of the following notification through email from tenderwizard portal, bidder must resubmit the bid even if the bidder has already submitted the bid through tenderwizard portal.

Notification: If you have already submitted the tender, then ensure that you resubmit the tender. Else, your bid may be liable to be auto disqualified by the system. And service provider holds no responsibility for the same. In case, you are yet to submit the tender, then please ensure that you submit it before the tender closing time.

Submission / resubmission of the bid is the responsibility of the bidders only. Bidder should check and confirm at their end regarding the submission/ resubmission of their bid till the due date & time of bid submission. BNPM / Keonics/ Tenderwizard will not be responsible for non-submission/ non resubmission of any bid.

4. Bid submission procedure:

Online bids: Tenders are to be uploaded on e-tendering portal www.tenderwizard.com/BNP only in Two-part bid system.

i) Part-I - Prequalification Bid & Techno-commercial Bid: Registration Fee, Tender Processing Fee, EMD/Bid Security Declaration as per Annexure A is to be submitted (For MSE Bidder) ,Scanned copy of supporting documents related to eligibility criteria (As mentioned in NIT) along with all sections , annexures of this tender (except Sec – IV, Price Schedule , which has to be submitted as mentioned in Sl.No.ii below) duly signed & stamped by authorized person in each & every page. (To be submitted through E-portal only)

ii) Part II – Price Bid: Price Bid shall be submitted through e-portal only, the price bid is liable for rejection if submitted in any other mode. Price Bid should be submitted as per the price bid format provided in Sec –IV, Price Schedule of this tender. **Price Bid submitted in any other format will be liable for rejection. Price bids with conditions / Counter conditions are liable for rejection.**

6. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected. In line with evaluation criteria bid may be submitted item/schedule wise.

6. **Bid Validity**: The tender shall remain open for acceptance for a period of 120 days from the date of opening of the tender.

7. **EVALUATION CRITERIA:**

7.1 At first stage, techno-commercial bid will be opened and evaluated by the competent committee / authority with reference to the parameters prescribed in the tender document. Subsequently in the second stage the financial bids of only techno commercially acceptable offer as decided in first stage shall be opened for further scrutiny and evaluation.

7.2 **The method of evaluation of price for awarding the Annual rate Contract shall be on schedule/item wise H1 basis against quoted effective prices (i.e without GST) only.**

If the schedule wise H1 rates are same for multiple bidders then the rate contract will be issued on both the bidders as parallel contract with same H1 rate.

Subsequently when required, sale orders will be issued against Annual Rate Contract. For parallel contracts, sale orders will be issued on equal proportionate sale order quantity basis.

However, for parallel rate contracts if against any item/schedule the total sale order quantity to be ordered is non-divisible among parallel rate contract holders (with same quoted H1 price), then at first sale order quantity to be ordered will be shared in equal proportionate basis among the parallel rate contract holders. Afterwards the balance quantity (if any) will be allotted to the parallel rate contract holder allotted with the maximum number of items/schedules under Annual Rate contract.

7.3 However, the acceptance of the tender will rest with BNPM, who does not bind himself to accept the highest tender and reserves to himself the authority to reject any or all of the tenders received without assigning any reason thereof.

- 7.4 BNPM also reserves the right to allot the order partly or wholly to single or different Tenderer. BNPM reserves the right to reject any offer including the highest one if the same is not conforming to its norms. The decision of BNPM in this regard will be final.

8. **Discrepancy in Prices:**

- 8.1 If, in the price structure quoted by a bidder, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price will be corrected accordingly, unless BNPM feels that the bidder has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.
- 8.2 If, there is an error in a total price, which has been worked out through addition and/ or subtraction of subtotals, the subtotals shall prevail and the total corrected; and
- 8.3 If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.
- 8.4 If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the bidder by registered/speed post/email. If the bidder does not agree to the observation of BNPM, the tender is liable to be ignored.

9. **Earnest Money Deposit (EMD):** Interest free EMD of **Rs 60,000/- (Rupees Sixty Thousand only)**. The EMD shall be paid through online at e-tender portal (www.tenderwizard.com/BNP). The tender without EMD shall be liable for rejection.

EMD is to be furnished by unregistered bidders only. Bidders registered with BNPM have to submit a declaration in letter head (Refer Annexure D) declaring them as registered bidders with BNPM mentioning Customer Code as provided by BNPM (as mentioned in the sale orders issued by BNPM) seeking EMD exemption.

For MSE Bidders:

- a) Submission of EMD is exempted for Micro and Small enterprises (MSEs) as per the Public Procurement Policy for MSEs Order, 2018.
- b) MSEs should be registered and also will continue to remain registered during the tender validity period with District Industries Centre (DIC) or Khadi and Village Industries Commission (KVIC) or Khadi and Industries Board (KVIB) or Coir Board or National Small Industries Commission (NSIC) or Directorate of Handicrafts and Handlooms or UDYAM Registered or Any other body specified by Ministry of MSME.

Note:

- i. Micro and Small Enterprises (MSEs) having major activity as “Manufacturers” and “Service Providers” as per UDYAM certificate are eligible for claiming EMD exemption. EMD exemption can be claimed irrespective of NIC code specified in UDYAM certificate.
- ii. An enterprise re-classified to “Medium” as per UDYAM Certificate may continue to avail EMD exemption from the enterprise type it was in before the re-classification (i.e. Small/Micro), for a period of three years from the date of such re-classification. An enterprise classified continuously

as “Medium” beyond three cannot claim EMD exemption.

- iii. MSME's having major activity as “**Trading**” for availing benefits of Priority Sector Lending (PSL) only as per UDYAM certificate are excluded from claiming EMD exemption. Such bidders are required to submit EMD as per tender, else their bid will be considered ineligible/ unresponsive and will be ignored.

For Start-up Bidders:

1. Submission of EMD is exempted for Start-up bidders as per the Office Memorandum No. F/20/2/2014-PPD (Pt.) of Ministry of Finance dated 25.07.2017.
2. Start-ups should be registered with Department for Promotion of Industry and Internal Trade (DPIIT) is to be submitted.

Documents to be submitted:

- i. For MSE Bidders: Valid UDYAM Registration certificate.
- ii. For Start-ups: Certificate of recognition issued by DPIIT.
- iii. Bid Security Declaration as per Annexure-A is to be submitted by bidders claiming exemption to EMD.

Note: Valid means valid upto Tender/bid validity period.

For Non-MSE/Start-up bidders: EMD is to be submitted, else bid will be rejected.

For successful bidders (unregistered / if any registered bidder has submitted EMD), interest free EMD amount will be released on submission of security deposit amount, if security deposit is submitted in form of BG then EMD will be released after confirmation of BG from respective Bank. The earnest money shall be valid for a period of forty-five days beyond the validity period of the tender. Unsuccessful tenderers' earnest money will be returned to them without any interest, after expiry of the tender validity period, but not later than thirty days after conclusion of the resultant contract. Successful tenderer's earnest money will be returned without any interest, after receipt of performance security from that tenderer.

10. **Performance Security/Security Deposit (SD):** After issuance of Annual rate contract, sale orders will be issued. Within ten (10) days after the issue of each sale order against Annual rate contract issued by BNPM, the successful bidder shall furnish performance security to BNPM for an amount equal to ten (10) per cent (%) of the total value of the contract which shall remain valid upto 60 days beyond the contract period of one year.

Performance security may be furnished in the form of:

- i. Account payee demand draft
- ii. Unconditional Bank Guarantee issued and confirmed from any scheduled commercial bank in India
- iii. Fixed deposit receipt (FDR) from a scheduled commercial bank in India, lien marked to Bank Note Paper Mill India Pvt Ltd, Mysore
- iv. Online payment in an acceptable form.
- v. Banker's cheque
- vi. Insurance surety bond

If the successful bidder fails to resume/complete the work within stipulated time, security deposit of such bidder shall be forfeited. SD shall be interest free. **If the successful bidder fails to submit the Security Deposit & does not lift the scrap material within 2 months of order placement, then BNPM has the right to cancel the order & debar that bidder.**

11. **Terms of Sale:**

Against each sale order (issued against Annual rate contract), Successful Bidder has to submit advance amount which is equivalent to the value of the scrap to be lifted preferably 3 days before lifting the material. The advance payment should be made vide electronic transfer/ Deposit to the Bank Account of Bank Note Paper Mill India Pvt Ltd. Successful Bidder shall be allowed to lift the material only if the advance amount is equivalent to the scrap to be lifted.

12. **Site Visit/ Inspection:** To assess the state/ conditions of scrap to determine the price to be quoted, the Bidder is advised to visit the project site before bid submission due date and time to get acquainted with the conditions at the site.

For visiting BNPM, Mysore plant prior permission is to be taken by prospective bidders from competent authority at BNPM, Mysore. Email may be sent at scm.tender@bnpmindia.com in this regard.

13. **Rate Contract Terms:**

- a) In the List of Requirement, no commitment of quantity is mentioned: only the anticipated requirement is mentioned without any commitment.
- b) BNPM reserves the right to conclude more than one rate contract for the same item.
- c) **Validity of Rate Contract:** Currency of the rate contract will remain valid for one year from the date of issuance of Annual Rate Contract. During the currency of the Rate Contract, BNPM may withdraw the rate contract by serving suitable notice of thirty days.
- d) **Renewal of Rate Contract:** In case, it is not possible to conclude new rate contracts before the expiry of existing ones due to some special reasons, the existing rate contracts would be extended with same terms & conditions, scope, rates for a suitable period, with the rate contract holders. Period of such extension would generally not be more than three months.
- e) During the currency of the Rate Contract, BNPM would have the option to renegotiate the price with the rate contract holders (scrap disposers).
- f) During the currency of the Rate Contract, in case of emergency, BNPM may dispose the same item through ad hoc contract with a new scrap disposer.
- g) The terms of sale in rate contract is Ex-works- BNPM, Mysore basis.
- h) Sale orders, incorporating definite quantity of scrap items to be disposed of from BNPM, Mysore plant along with all other required conditions following the rate contract terms, will be issued by BNPM for disposing scrap items vide sale through the rate contract.
- i) BNPM is entitled to place sale orders up to the last day of the validity of the rate contract and, though disposal against such sale orders will be affected beyond the validity period of the rate contract, all such sale orders will be guided by the terms & conditions of the rate contract.
- j) If the rate contract holder (scrap disposer) increases its price or purchases or even offers to purchase the rate contracted scrap items, following conditions of purchase similar to those of the rate contract, at a price higher than the rate contracted price, to any person or organization during the currency of the rate contract, the exiting rate contracted price (with BNPM) will be automatically increased with effect from that date for all the subsequent purchases under the rate contract and the rate contract will be amended accordingly. Any

violation of this clause would be considered as a serious misdemeanor and action, as appropriate, would be taken as per provision of this clause.

14. **Completion Time, free delivery time, ground rent:** Work for lifting the available scarp materials shall be started within 10 working days of issue of Sale Order and lifting of the available scrap should be finished within 30 days (free delivery period) from the date of issue of Sale Order. The scrap materials available thereafter shall be lifted as and when available and as per the sale orders existing/issued and subsequent schedule provided by BNPM for disposal up to a period as per the sale order with same ordered price and terms & conditions. The delivery of material will be given only against advance payment. If the successful bidder (purchaser) fails to lift the material within the free delivery period i.e 30 days (initial), then the purchaser may request for an extension. Such extensions may be granted after levying a ground rent at ½ % (half percent) of the sale value per day. Subsequently, against each schedule as provided by BNPM any delay beyond 15 days in lifting the scrap items may attract a ground rent at ½ % (half percent) of the sale value per week maximum upto 10% of the sale value. However, the levy of ground rent may be waived as per the discretion of BNPM and considering the genuinely of the case.
15. **Procedure for Disposal of Hazardous wastes:** On finalization of tender, Annual Rate Contract will be issued, subsequently sale orders will be issued to successful bidder by BNPM for the existing available quantity, which has to be completed lifting within 30 days from the date of issue of sale order. The contractor shall make advance payment as mentioned above for the material to be lifted.

Scraps are to be lifted "As Is; Where Is; Whatever Is "basis. No picking, choosing, sorting, welding, cutting or breaking of Goods or materials sold will be permitted unless otherwise specified. In used/waste oil, separation of oil and water, and so on, shall not be allowed at the site. If these actions are allowed. If any foreign materials are found to be mixed in the lot, other than the items included in the sale order, the seller reserves the right to remove them at the time of delivery. The Successful Bidder (buyer/scrap disposer) shall not be entitled to re-sell an item, lot or part of a lot while the Goods are still lying within the premises of the seller and any such sale or assignment of the Successful Bidder's (buyer/scrap disposer) right to the material sold will not be recognized. All documents for releasing materials will be made out in the name of the buyer only. Successful Bidder (buyer / scrap disposer) shall arrange vehicle, if any, Tools & tackles /materials required & labour for collection from various places in the site, loading, transportation at their own cost. The safety of the labour will be the responsibility of the Successful Bidder. The operation is to be completed within the specified office hours i.e. between 1000 hrs and 1600 hrs. No work shall be permitted on Sundays or on closed holidays.

Successful Bidder shall not be allowed to pick and choose the materials. Hazardous waste has to be lifted as per the instruction of BNPM only. This material should not be sold to the employees of BNPM. Undertaking this regard has to be provided. The scrap material will be delivered only to the successful bidder or their authorized representatives against the presentation of the buyer's identity proof. If the successful bidder desires to authorize a representative or an agent to accept delivery, the bidder shall produce a suitable power of attorney or authorization letter for each lot separately, duly attested, by a notary public authorizing their representative or agent to lift the material from the seller.

16. **Termination of contract:** Successful bidder should adhere the schedule of lifting of the scrap as provided by BNPM time to time. During the execution of the contract if the performance of the bidder is found unsatisfactory BNPM has the right to (i) Terminate the contract (ii) Forfeit the security deposit amount (iii) Debar the bidder.
17. **Compliance of security Norms:** BNPM is a security organization located in the premises of BRBNMPL and the Govt. of Karnataka declares the premises as Prohibited Area. Hence the contractor has to abide by the security rules of the Company. The contractor has to ensure the character and antecedent of the persons deployed. The contractor must be in a position to produce such documents whenever he is asked to do so. Details shall be furnished as per format when called for. The contractor has to issue printed photo identity card to its workers duly authenticated by the designated security officer of the Company. Contractor should apply for Gate Pass for labours, welding permission and material entry pass etc. as per approved format only, well in advance to avoid any delay in issue of Gate passes.
18. **Default be successful bidder:** Materials sold but not removed within the specified date will become the property of the seller and it will have the right to dispose of such Goods in any manner as he deems fit without any notice. Successful bidder to ensure the validity of their passbook for the entire contractual period and non-lifting of the scrap material due to expired passbook may result into imposition of ground rent as per the discretion of BNPM.
19. Under Annual Rate Contract, quantity mentioned is anticipated quantity only and there is no commitment of quantity. BNPM reserves the right to increase or decrease the quantity of any item or items or terminate the contract at any stage by giving thirty days' notice. No claim whatsoever shall lie against the BNPM on account of such termination of the contract or variation in the quantity. BNPM shall have the right to remove certain items which it feels were not intended for sale but were inadvertently made a part of the scrap material or of the lot offered for sale lying at the premises or were joined or attached to the material offered for sale. Tenderers desirous of purchasing and participating in the tender must visit the site before submitting the offer, after taking due permission from the concerned Stake Holders. The Tenderers submitting the offers shall be deemed to have visited the site and acquainted themselves thoroughly with materials intended for sale in all respect. Any person giving offer shall be deemed to have made himself fully conversant with the Terms and Conditions of the Tender Sale, as well as the location and condition of the materials being sold and shall be deemed to have agreed to all the stated terms and conditions herein under.
20. **Tax:** TDS, TCS as applicable under Income Tax & GST regime are to be complied.

All the above terms and conditions, scope of work have been read, understood and accepted by me.
