### 1.0 <u>Introduction</u>

Power to whole plant is distributed from 1 Nos. main receiving station called 66kV Switchyard and 6 Nos. of distribution substations called Paper machine-1, Paper machine-2, Pulp mill, Utility, ETP and Mini Press Sub-stations.

#### 2.0 <u>Specification of Thermographer and camera:</u>

- a. Infrared Thermographer shall be person with technical qualification with trained Level –
  1 / 2 through certification course on Infrared Thermography (Electrical). Corresponding certificate is to be submitted by bidder for techno commercial evaluation.
- b. Infrared Thermographer Level 2 with 3 years' experience (or)

Infrared Thermographer Level 1 with 5 years' experience shall be deputed for analyzing & provide recommendation on thermal images. Detail of technical qualification and experience of Thermographer is to be submitted for techno commercial evaluation.

c. Bidder should have good quality & very high-resolution thermography camera like Fluke, Flir etc suitable for electrical equipment listed in scope of work. Detail of the camera is to be submitted by bidder for techno commercial evaluation.

#### Scope of work:

- Providing the Thermography Services with equipment and competent manpower for the electrical installation system (list mentioned below).
- Checking of the Temperature profile to detect hot spots using Thermal Imaging Camera. Tracing hotspots from one end to other to ascertain the cause of abnormal heating.
- Analysing of the thermography report and give detailed report and recommendation for the remedial measures to be taken.
- Hotspots identified shall be categorized as **Alarming, Caution, Check & Monitor** and recommendation to rectify the same may be provided.
- Post Thermography test shall be carried out after repairing of hotspots (if any identified by the bidder during Thermography) by BNPM. No additional claim for deputation of manpower for post thermography shall be applicable.

### 2.0 <u>Tools and Tackles:</u>

- 2.1.1 All tools and tackles required for thermography survey such as Thermal Image Camera etc if any will be in the scope of bidder.
- 2.1.2 Only valid calibration certificate tools to be used for the survey.

### 3.0 <u>Training</u>

Bidder to provide onsite training for BNPM technical team including both classroom & hands-on training covering different aspects of thermography, types of thermography, details of electrical thermography with examples etc.

### 4.0 <u>General Instructions to the bidder:</u>

- 1) The bidder shall take full responsibility for supervision and proper execution of works covered under the scope of contract. The work should be executed in through professional way & in true workmanship. The work will be carried out without hampering / disturbing day to day functioning of the BNPM. Any damage caused to BNPM machinery or any other assets inside BNPM premises by and any deliberate efforts to effect/hamper the production of the plant by the bidder or his/her team shall be made good or replaced at cost of the bidder only.
- 2) The bidder shall be held responsible for any violation of statutory regulations local, state or central and BNPM instructions, that may endanger safety of men, equipment, material and environment in his scope of work or another bidder"s or agency"s. Cost of damages if any, to life and property arising out of such violation of statutory regulations and BNPM instructions, shall be borne by the bidder.
- 3) Bidder shall have to submit the valid calibration certificate of the requisite instruments before the start of work. In case validity of certificate expires during the pendency of the job, bidder has to produce the revalidated certificates; otherwise, they will not be allowed to carry out the



thermography job. Expenses in this regard, if any, shall have to be deemed to be included in the quoted price and no separate charge shall be paid for what so ever.

- 4) Bidder should ensure the safety of his work personnel while carrying out the thermography job. Supply of all necessary safety gadgets are in the scope of bidder.
- 5) The bidder personnel engaged in thermography survey job shall have to obtain entry pass from BNPM Security & Safety department / Individual Section Heads authority for entering in BNPM's secured areas / installations.
- 6) The bidder may visit / inspect the BNPM installations at their own cost with prior permission of BNPM, if required, before submitting the offer.
- 7) The expenses towards transportation of man & materials, data collection, accommodation (food & lodging) of personnel, local transport & travel, expenses towards draft & final report preparation, delivery & report presentation etc. will be in the scope of bidder.
- 8) The bidder has to submit the draft reports within 2 weeks after carrying out Thermography Survey of each installation/ building/premises or as advised by Head-Technical Audit and BNPM Management
- 9) If any of the report is found to be unsatisfactory by BNPM, bidder has to rectify the same within 1 week at their own cost.
- 10) Copy of final draft report incorporating the change(s) should be sent to BNPM before finalization of the report within a week. Final report shall be submitted within 1 month from the date of completion of Thermography Survey.
- 11) One (1) sets of hard copies of final thermography survey reports of each installation/ building/premises with proper binding should be submitted within 10 days from the date of acceptance by BNPM. Soft copies of all the audit reports must also be submitted.
- 12) The successful bidder shall mobilize all their resources including manpower and start the work at location mentioned in the tender within 2 weeks from the date of issuing work order.

The bidder shall familiarize themselves with and be governed by all laws and rules of India and Local statutes and orders and regulations applicable to his/her their work.

### A. ELIGIBILITY CRITERIA:

### Experience & past performance:

- a) Bidder should have carried out minimum 1 No Thermography survey work on electrical equipment in last 5 years ending on 30.11.2024.
  - (i) Order / Contract awarded to the bidder.
  - (ii) Documentary evidence against successful completion of the corresponding order/contract.
- b) Company's registration / Certificate of incorporation/Partnership Deed/Any other registration certificate as applicable
- c) Copy of GST certificate and PAN

### B. Documents to be submitted in e tender portal:

- c) All the documents mentioned under **eligibility criteria** (Point C) which are as follows:

- **e)** Infrared Thermographer Level 2 with 3 years' experience (or) Infrared Thermographer Level 1 with 5 years' experience: Detail of technical qualification and experience of Thermographer is to be submitted for techno commercial evaluation.
- **f)** Bidder should have good quality & very high-resolution thermography camera like Fluke, Flir etc suitable for electrical equipment listed in scope of work. Detail of the camera is to be submitted by bidder for techno commercial evaluation.
- **g)** Micro / Small Enterprise (Certificate issued by MSME): UDYAM Registration certificate (If applicable).

#### C. TERMS & CONDITIONS:

- 1. **Price:** Price should be inclusive of P&F, Freight, Transit Insurance, TA, DA, Fooding, Lodging and GST and any other charges as required to complete the entire work. Price shall remain fixed & firm and no price variation shall be accepted till completion of contract.
- 2. Terms of Payment: 100% payment shall be made within 30 days completion of entire work at BNPM Plant, Mysuru and on production of all required documents by the successful bidder. NEFT/RTGS details shall be furnished along with the Original Invoice.
- **3.** Address for providing service: Location of Performance/service to be provided: Work is to be performance at Bank Note Paper Mill India Pvt. Ltd., Note Mudran Nagar, Mysore 570003.
- **4. Delay in successful bidder's performance:** Time for and the date specified in the contract or as extended for the performance of the services shall be deemed to be the essence of the contract and the successful bidder shall deliver the goods and perform the services under the contract within the time schedule specified by BNPM in the contract.

Any delay attributable to the successful bidder in maintaining its contractual obligations towards delivery of goods and performance of services shall render the successful bidder liable to any or all the following sanctions besides any administrative action such as (a) Imposition of liquidity damages; (b) Termination of contract for default.



**5. Extension of Time:** If the contract is delayed in the progress of work by changes ordered in the work, or any clause which BNPM shall decide to justify the delay, then the time of completion shall be extended by a reasonable time.

If at any time during the currency of contract, the successful bidder encounters conditions hindering timely performance of services, the successful bidder shall promptly inform BNPM in writing about the same and its likely duration and make a request to BNPM for extension of the delivery schedule accordingly. On receiving the successful bidder's communication, BNPM shall examine the situation as soon as possible and, at its discretion, may agree to extend the completion period, with or without liquidated damages for completion of successful bidder's contractual obligations by issuing an amendment to the contract.

**6. Risk Purchase Clause:** If the successful bidder fails to abide by the terms and conditions of the contract/agreement, or fails to performance service as per the completion schedule or any time repudiates the contract,

Render service from other agencies at the risk and cost of the successful bidder. The cost difference between the alternative arrangement and existing contract value wherein default has been made will be recovered from the successful bidder along with the other incidental charges. In case of procurement through alternative sources, if procurement price is lower than the existing contract value wherein default has been made, in such case no benefit on this account will be passed on to the successful bidder.

- **7. Termination for Convenience Clause:** BNPM reserves the right to terminate the contract, in whole or in part for its (BNPM's) convenience, by serving written notice on the successful bidder at any time during the currency of the contract. The notice shall specify that the termination is for the convenience of BNPM. The notice shall also indicate inter-alia, the extent to which the successful bidder's performance under the contract is terminated, and the date with effect from which such termination will become effective.
- **8. Settlement of Disputes through Arbitration:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after their completion except accepted matters shall be settled through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysore, Karnataka.
- **9. Legal Jurisdiction:** The Courts of Mysore (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.
- **10.** Force Majeure: In the event of any unforeseen event directly interfering with the performance of service arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the successful bidder shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force



majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.

- **11. Liquidated Damage:** If the successful bidder fails to perform the services within the time frame(s) incorporated in the contract, BNPM shall, without prejudice to other rights and remedies available to BNPM under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% (Half) percent of the contract price of the delayed work for each week of delay or part thereof until actual contract period, subject to a maximum deduction of 10% of the delayed contract price(s).
- **12. Rights of Rejection:** BNPMIPL reserves the right to reject any or all the applied bids without assigning any reason whatsoever. The enquiry can be rejected on national security grounds.
- **13. Evaluation Criteria:** Techno commercial bid will be opened at first. The bidders qualifying techno commercially shall be considered for price bid opening. Price evaluation shall be carried out on the basis of **overall effective price** (i.e without GST) quoted by the bidder and the contract shall be awarded to the overall lowest (L1) bidder.

### 14. Price discrepancy:

- i. If, in the price structure quoted by a tenderer, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless BNPM feels that the tenderer has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.
- ii. If there is an error in a total price, which has been worked out through addition and/ or subtraction of subtotals, the subtotals shall prevail and the total corrected; and
- iii. If there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.
- iv. If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the tenderer by registered/speed post. If the tenderer does not agree to the observation of BNPM, the tender is liable to be ignored.
- v. If there is any tie between the quoted L1 rates of the bidders then preference will be provided to the company which was constituted earlier.
- vi. Note: In techno commercial bid, Bidders have to mandatorily submit Company's registration / Certificate of incorporation/Partnership Deed/Any other registration certificate as applicable substantiating documentary evidence pertaining to date of constitution of the company.

### 15. Taxes:

All Taxes shall be as applicable in GST regime. Payment of CGST, SGST, IGST & UTGST: The successful bidders are required to adhere the following procedure in order to honour the payment against CGST, SGST, IGST & UTGST in the invoice.



- i) An invoice issued by the vendor for goods or services or both as applicable should be in accordance with the provisions of Sec 31 of the CGST Act & should contain all the prescribed information's in accordance with Chapter VI of CGST rules 2017.
- ii) A debit note issued if any, by the vendor should be in accordance with the provisions of Sec 34 of the CGST Act.
- iii) The vendor should mandatorily upload the aforementioned documents in respective GSTR, details of outward supplies of goods or services as applicable within the prescribed time under GST Act.
- iv) The vendor should provide the relevant documents to confirm the tax charged on the invoice has been paid to the credit of government after adjusting the ITC if any.

Notwithstanding the above, the successful bidder should provide indemnification as follows:

In the event of non-compliances with respect to GST Act & Rules by the successful bidder, the purchaser is allowed to adjust the GST amount from retention amount (either in BG or in cash) held by the company. If no amount is available for recovery, the successful bidder will refund the GST liability within 10 days from the date of GST reversal in GSTRN.

The above requirements are mandatory to claim any GST liability, falling which, the GST liability will not be paid /reimbursed/accepted.

### A. <u>The bidder should consider the following points while quoting GST Rate in their bids:</u>

- 1. In case of unregistered bidders, the rate and amount of GST shall be shown as "Nil".
- 2. In case of a compounding dealer, GST shall be quoted as "Nil" as compounded dealers cannot collect GST from the consumers. The price quoted therefore shall be construed as all inclusive.
- 3. In case of work contracts or pure labour contracts, the bidder shall quote single GST rate for the work.
- 4. In case of composite supplies, i.e., a supply consisting of one principal supply and other ancillary supplies, the supply will attract the GST Rate of the principal supply. For example, if Item A in the supply order is the major or principal supply and other items are ancillary supplies, the bidder shall quote the GST Rate applicable to the principal goods (i.e., Item A) being supplied.
- 5. In case of mixed supply, i.e., a combination of two or more individual goods made together for a single price (each of these items can be supplied separately and is not dependent on any other), the total supply will attract the GST rate of the item which has the highest rate of tax. For example, if Item A in the mixed supply attracts highest rate of tax, the bidder shall quote the GST rate applicable to item A for total mixed supply.
- 6. In case of supplies which are neither composite nor mixed supplies, the bidder shall quote the GST Rate applicable to each item of supply separately.
- 7. If there is any difference of opinion regarding classification in HSN code, the bidder should seek clarification/raise query within the given time from the date of tender and it would be clarified before submitting the bid. Once clarified then that will be final & binding and no deviation shall be granted.



# B. <u>Other instructions for the bidders to claim any GST liability</u>, failing which, the GST liability will not be paid/reimbursed/accepted:

- 1. Registered/compounding Contractor/ successful bidder should produce GST Invoice containing all the particulars stated in Rule 46 of the CGST Rules, 2017 in accordance with the provisions of Section 31 of the CGST ACT.
- 2. The successful bidder should mandatorily update the invoice details in GSTR-1, details of outward supplies of goods or services within the prescribed time under GST Act
- 3. The Payment shall be made net of TDS as per the provisions of CGST/SGST/IGST Act.
- 4. Wherever there is difference in the amount admitted, the successful bidder may be directed to issue a Credit Note (in case of reduction in the Invoice value)/Debit Note (in case of increase in the Invoice value), and payment shall be released only after the receipt of such Debit or Credit Note
- 5. The successful bidder should provide the relevant documents to confirm the tax charged on the invoice has been paid to the credit of Government after adjusting with ITC, if any.
- 6. The successful bidder should provide indemnification as follows: "In the event of noncompliances with respect to GST ACT and Rules by the successful bidder, the successful bidder should refund the GST liability within 10 days from the date of GST reversal in GSTRN failing which the purchaser shall recover the GST amount from the retention amount (whether in BG or in Cash) held by the company".
- **16. Tax deduction at source:** All statutory deduction as applicable shall be deducted at source as per rules at prevailing rates, unless certificate, if any, for deduction at lesser rate or nil deduction is submitted by the Successful bidder from appropriate authority. The successful bidder shall provide accurate particulars of PAN number as required, under Section 206AA of Income Tax Act 1961.
- **17. Tax Collection at source:** Finance Act, 2020 also inserted sub-section (1H) in section 206C of the Act which mandates that with effect from 1st day of October, 2020 a seller receiving an amount as consideration for sale of any goods of the value or aggregate of such value exceeding Fifty Lakh Rupees in any previous year to collect tax from the buyer a sum equal to 0.1 per cent (subject to the provisions of proposed sub-section (10A) of the section 206C of the Act) of the sale consideration exceeding Fifty Lakh Rupees as income-tax. The collection is required to be made at the time of receipt of amount of sales consideration.
- **18. Insurance:** The deployed personnel (at BNPM, Mysore) by the successful bidder should be suitably covered under valid medical and life insurance before deployment at BNPM, Mysore

### **19. Compensation for damages:**

In case any damage is caused to BNPMIPL due to negligence, carelessness or inefficiency of staff of the agency, the agency shall be responsible to make good the loss. #### Land Border Clause

- \*Any bidder from a country which shares a land border with India will be eligible to bid in the tender only if the bidder is registered with the Competent Authority (The Registered Committee constituted by the Department for Promotion of Industry and Internal Trade).
- II) Bidder means any person or firm or company, including any member of a consortium or joint venture (that is an association of several persons, or firms, or companies), every artificial judicial person not falling in any of the descriptions of bidders stated hereinbefore, including any agency branch or office controlled by such person participating in a procurement process.
- III) "Bidder from a country which shares a land border with India" for the purpose of this order means:
  - a) An entity incorporated, established or registered in such a country; or

b) A subsidiary controlled through entities incorporated, established or registered in such a country, or

c) An entity substantially controlled through entities incorporated, established or registered in such a country, or

- d) An entity whose beneficial owner is situated in such a country; or
- e) An India (or other) agent of such an entity; or
- f) A natural person who is a citizen of such a country; or

g) A consortium or joint venture where any member of the consortium or joint venture falls under any of the above.

IV) The beneficial owner for the purpose of (iii) above will be as under: -

1) In case of a company or limited liability partnership, the beneficial owner is the natural person (s), who, whether acting alone or together, or through one or more judicial person, has a controlling ownership interest or who exercise control through other means.

Further explanation:

a) "Controlling ownership interest" means ownership of or entitlement to more than twenty five per cent of shares or capital or profits of the company;

b) "Control" shall include the right to appoint majority of the director or to control the management or policy decision including by virtue of their shareholding or management rights or shareholder agreements or voting agreements;
