- 3. **Risk Purchase Clause:** If the successful bidder fails to abide by the terms and conditions of this agreement, or fails to provide service as per the schedule or any time repudiates the contract, BNPM will have the right to recover the cost difference between the alternative arrangement and existing contract value wherein default has been made from the contractor along with the other incidental charges. In case of procurement through alternative sources, if procurement price is lower than the existing contract value wherein default has been made, in such case no benefit on this account will be passed on to the supplier.
- 4. **Force Majeure**: If at any time during the execution of the order, the performance in whole or in part by either party of any obligation under this Order is prevented or delayed by reason of any war, hostility, acts of public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts or acts of God (hereinafter referred to as "events") provided notice of happenings of any such eventuality duly endorsed by the appropriate authorities/chamber of commerce in the country of the party giving notice, is given by party seeking concession to the other as soon as practicable but, within 7days from the date of occurrence and termination thereof and satisfies the other party adequacy of the measure taken by it, neither party shall by reason of such event, be entitled to cancel the Order nor shall either party have any claim for damages against the other in respect of such non-performance or delay in performance, and deliveries under the Order shall be resumed as soon as practicable after such event has come to an end or ceased to exist and the decision of, BNPM, as to whether the services have so resumed or not, shall be final and conclusive, provided further, that if the performance in whole or in part or any obligation under this Order is prevented or delayed by reason of any such event for a period exceeding 60 days, BNPM, may at his option cancel the Order.
- 5. **Bid Validity:** The tender shall remain open for acceptance for a period of 120 days from the date of opening of the tender.

6. Evaluation Criteria:

- a. At first stage, techno-commercial bid will be opened and evaluated by the competent committee / authority with reference to the parameters prescribed in the tender document. Subsequently in the second stage the financial bids of only techno commercially acceptable offer as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.
- b. The method of evaluation of price bid for determining L1 status shall be on the basis of overall effective price basis (i.e without GST) only.
- c. However, the acceptance of the tender will rest with BNPM, who does not bind himself to accept the lowest tender and reserves the authority to reject any or all of the tenders received without assigning any reason thereof.
- d. If there is any tie between the quoted L1 rates of the bidders then preference will be provided to local bidders i.e a bidder having head office at Mysore.

7. **Discrepancy in Prices**:

- a. If, in the price structure quoted by a tenderer, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless BNPM feels that the tenderer has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.
- b. If, there is an error in a total price, which has been worked out through addition and/ or subtraction of subtotals, the subtotals shall prevail and the total corrected; and
- c. If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail.
- d. If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the tenderer by registered/speed post/email. If the tenderer does not agree to the observation of BNPM, the tender is liable to be ignored.
- e. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected.
- 8. **Liquidated Damage**: If the successful bidder fails to provide any or all of the services or fails to perform the services within the time frame(s) incorporated in the contract, BNPM shall, without prejudice to other rights and remedies available to BNPM under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to the 0.5% (Half) percent of the delivered service price of the delayed services for each week of delay or part thereof until actual delivery or performance, subject to a maximum deduction of the 10% of the delayed services' contract price(s).
- 9. **Penalty:** In addition to above if any penalty / interest / compensation paid to statutory Authority due to negligence / omission / commission / mistake / error occurred during performance of services would be recovered from the contract price at actual basis.

10. Number of Proposals and respondents

No Bidder or its Associate shall submit more than one Proposal, in response to this RFP. A Bidder applying individually or as an Associate shall not be entitled to submit another Proposal. Any Bidder which submits or participates in more than one tender/proposal would be disqualified

- 11. **Terms of Payment:** Payment shall be released within 30 days after completion of the execution of order. Payment shall be released in INR vide electronic transfer. TDS shall be deducted as applicable.
- 12. **Tenure of Contract:** The work is to be completed within 31.08.2024.
- 13. **Signing authority of bid documents:** Bid document should be signed by an authorized person. For Ltd/ Pvt ltd company authority not less than the rank of Director should sign the bid document, else if signed by any other person then the the person should be authorized for signing the bid document vide Board Resolution/ Power of Attorney (Rs. 200 stamp paper authorized by Managing Director). If the bidder is proprietary firm then proprietor should sign the documents else the person should be authorized by Power of Attorney (Rs. 200 stamp paper authorized by Proprietor).
