If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1 + 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY.

Buyer Added Bid Specific Terms and Conditions

1. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. PACKING: It is desired that the Non-Ferric Aluminium Sulphate (Alum). should be supplied in 50 kgs strong reinforced polythene bags and on the suitable pallet.
2. PACKING STANDARDS:
 - i. Every stack should be strapped with plastic strips (along the pallets)

to avoid falling & subsequent damages during transit.

- ii. Every stack should be wrapped in stretch film to form a compact block structure.
- iii. Supply in loose bags / uncovered bags / partially covered bags, half bags etc. will be rejected at supplier risk and cost .
- iv. Supplier should provide gross weight of each pallet along with weight of packing material (i.e. empty pallet weight, other packing material weight). It is required for calculating & cross checking net weight of received material.
- v. Sample will be taken from one bag out of 25 bags randomly, for lab testing.

Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization. Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specification and / or terms and conditions governing the bid. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
