1. Documents to be submitted:

2. Price: Price should be provided as per the format at Point 16. Price shall remain fixed & no price variation shall be accepted till completion of contract.

3. Contract Period: From the date of issue of Empanelment letter till 31.08.2023.

4. Terms of Payment: 100% payment shall be made within 7 days on the date of receipt of Invoice at BNPM Plant, Mysuru and on production of all required documents by the supplier. NEFT/RTGS details shall be furnished along with the Original Invoice.

5. Delivery Address: Foreign Currency shall be delivered to Bank Note Paper Mill India Pvt. Ltd., Mysore, Note Mudran Nagar, Mysore – 570003

6. Risk Purchase Clause: If the supplier fails to abide by the terms and conditions of the contract/agreement, or fails to supply the material as per the delivery schedule or any time repudiates the contract,

Procure the tendered item / render service from other agencies at the risk and cost of the supplier. The cost difference between the alternative arrangement and existing contract value wherein default has been made will be recovered from the supplier along with the other incidental charges.

In case of procurement through alternative sources, if procurement price is lower than the existing contract value wherein default has been made, in such case no benefit on this account will be passed on to the supplier.

7. Termination for Convenience (Foreclosure) Clause: BNPM reserves the right to terminate the contract, in whole or in part for its (BNPM's) convenience, by serving

written notice on the supplier at any time during the currency of the contract. The notice shall specify that the termination is for the convenience of BNPM. The notice shall also indicate inter-alia, the extent to which the supplier's performance under the contract is terminated, and the date with effect from which such termination will become effective.

- 8. Termination of Contract by BNPMIPL:** If the agency stops providing satisfactory service for more than 2 occasions continuously, then BNPMIPL has the right to terminate the Contract without giving any notice whatever may be the reason. In this case, the agency has no right to claim compensation. BNPMIPL has the right to award the contract to any other agency at the cost, risk and responsibilities of agency and excess expenditure incurred on account of this shall be recovered by BNPMIPL from pending bills/s or by raising a separate claim. Decision of BNPMIPL in this regard shall be final. The agency has no right to withdraw or leave the contract in mid before expiry of the term of the specified valid tenure of the contract.
- 9. Settlement of Disputes through Arbitration:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after their completion except accepted matters shall be settled through arbitration process as per the Indian Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysore, Karnataka.
- 10. Legal Jurisdiction:** The Courts of Mysore (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.
- 11. Force Majeure:** In the event of any unforeseen event directly interfering with the supply of stores arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the Contractor shall, within a week from the commencement thereof, notify the same in writing to the Purchaser with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.
- 12. Fore-Closure Clause:** If at any time during the continuation of this contract, the use of material ordered in this contract is completely banned or due to drastic change in Government policy its use as, raw material is discontinued or is declared hazardous to public health or cause rising to civil commotion, epidemics, wide-spread strikes and 21 days' notice of such eventualities is given by purchaser to the seller, the seller without any right to enforce the contract, will agree to the fore-close the

performance of balance portion of this contract and in that event no claim for damages or loss will be lodged against the purchaser.

13. Rights of Rejection: BNPMIPL reserves the right to reject any or all the applied bids without assigning any reason whatsoever. The enquiry can be rejected on national security grounds.

- iv) Bidder should not be blacklisted & no criminal case / case under FEMA should be pending against the bidder. Bidder to submit a declaration for the same.
- v) Bidder shall submit valid GST Registration Certificate and PAN Card.
- vi) Bidder shall provide the Incorporation certificate/relevant document establishing their incorporation.
- vii) The tenderer shall satisfy BNPMIPL that they are competent and authorized to submit tender and/or to enter into a legally binding contract with the BNPMIPL.
