- 1. Tenders are to be uploaded on e-tendering portal www.tenderwizard.com/BNP only in Two part bid system.
- i) <u>Part-I Prequalification Bid & Techno-commercial Bid</u>: Scanned copy of Technical offer (catalogue/brochure etc.), Certificate of Incorporation/Partnership Deed (as applicable), GST, PAN, Bank details etc., along with all sections & annexures of this tender.

ii) Part II - Price Bid:

Price shall be furnished through e-portal only. Price offer submitted in any other format will be liable for rejection.

3. Payment terms:

100% within 30 days from the date of completion of work and receipt and acceptance of reports by BNPM, Mysore on production of all relevant documents against respective orders.

Statutory Deductions as applicable shall be made from the gross bill amount. Payment shall be done in INR only.

- 4. **Work Completion Period / Schedule**: For any requirement within the ARC period, mutually agreed timeline for completion of the requirement will be decided. Accordingly, against ARC work order will be issued. Successful bidder to complete the work within the timeline mentioned in the order along with submission of requisite documents. Successful bidder shall complete the work based on requirement issued by BNPM with mutually agreed timeline along with all requisite documents. No change in work schedule shall be permitted without the written contract of BNPM, Mysore.
- 5. **Contract Period**: The contract shall be for a period of **12 months** from the date of issue of annual rate contract. However, based on satisfactory performance, BNPM reserves the right to extend the contract on yearly renewal basis for additional two (02) years with same price, terms & conditions and scope of work and at the discretion of BNPM, Mysore.
- 6. **Liquidated Damages:** In case your quotation is accepted and order is placed on you, the service against respective orders issued against ARC should be completed within the period stipulated in the respective orders. BNPMIPL reserves the right to recover any loss sustained due to delayed delivery by way of LD. Failure to services the material/ service within the stipulated period shall entitle BNPM to impose liquidated damages without assigning any reasons @ 0.5% (Half Percent) of the total value of the item covered in order as LD per week or part thereof subject to a maximum of 10% (Ten Percent) which you unconditionally and expressly agree to unless extension is obtained from BNPM without imposition of LD, without price escalation along with any other denial conditions (if applicable) on valid ground before expiry of delivery period.
- 7. Warranty: NA
- 8. **Performance Security:** Within twenty-one days after the issue of notification of award i.e., each order against ARC by BNPM, the successful bidder shall furnish performance security to BNPM for an amount equal to Five per cent (5%) of the total value of the order, valid up to sixty days after the date of completion of all contractual obligations by the supplier. - 9. All services are subject to inspection and approval before acceptance.
- 10. Bid Validity: 120 days from the date of opening of tender.

11. Evaluation Criteria:

- (i) The technical bids shall be opened in the first instance and these bids shall be scrutinized and evaluated by the competent committee/ authority with reference to the parameters prescribed in the tender document. Subsequently, in the second stage the financial bids of only technically acceptable offers as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.
- (ii) **Method of Evaluation:** Evaluation shall be carried out on **overall effective price** quoted by the successful bidders, unless any other method of evaluation is specifically provided in the enquiry and contract shall be awarded to **overall lowest (L-1) successful bidder**. The quoted price should be inclusive of P&F, Freight, to& fro transportation, fooding, lodging, boarding, Transit Insurance and any other charges required for delivery of services to BNPM, Mysuru on F.O.R basis.
- (iii) **Price Tie:** In case of a price tie at L-1 price for any schedule, company incorporated earlier among the tied parties shall be awarded order. In case of unavailability of incorporation certificates, such as proprietorship & partnership firms, date of GST registration & execution of partnership agreement respectively shall be taken as date of incorporation.
- (iv) All responsive tenderers shall be evaluated as per the terms & conditions of the tender. The basis for arriving at the lowest responsive successful bidder shall be as per the price quoted for landed cost at Mysuru including GST, packing & forwarding charges, freight, insurance and any other charges etc. and input credit shall be deducted to arrive at the effective price. Effective price shall be considered for arriving the lowest responsive successful bidder.
- (v) Successful bidder has to mention appropriate SAC code and quote GST rate provided in Price Schedule. In case of any mismatch in SAC code with respect to offered product, same shall be decided in consultation with winning successful bidder
- (vi) All tenderers should be registered under GST. They should be eligible to pass on input credit. Bid will be evaluated all-inclusive though input credit will be deducted to arrive at the effective cost.

*If the tenderer is unregistered, the GST shall be payable by the purchaser under reverse charge and shall be added to the quoted rate to arrive at the Gross price and input credit, if any shall be deducted from the total landed cost to arrive at the net comparable price. If no indication regarding GST is recorded in the quotation, the GST will be considered as

included.

- 12. Payment of GST is primarily the responsibility of the seller and will not be paid unless the percentage value is clearly mentioned in the quotations. If no indication regarding GST is recorded in the quotation, the GST will be considered as included. TDS will be deducted at GST & Income tax act.
- 13. **Delay in successful bidder's performance:** Time for and the date specified in the respective work order issued against ARC or as extended for the performance of service shall be deemed to be the essence of the respective work order issued against ARC and the successful supplier shall performance of service and perform the services under the contract within the time schedule specified by BNPM in the respective work order issued against ARC.
 - Any delay attributable to the successful supplier in maintaining its contractual obligations towards delivery of goods and performance of services shall render the supplier liable to any or all the following sanctions besides any administrative action such as (a) Imposition of liquidity damages; (b) Termination of contract for default; (c) Forfeiture of performance security.
- 14. **Extension of Time:** If the respective work order issued against ARC is delayed in the progress of work by changes ordered in the work, or any clause which BNPM shall decide to justify the delay, then the time of completion shall be extended by a reasonable time.
 - If at any time during the currency of work order, the successful bidder's encounters conditions hindering and performance of services, the successful bidders shall promptly inform BNPM in writing about the same and its likely duration and make a request to BNPM for extension of the work completion period/ schedule accordingly. On receiving the successful bidder's communication, BNPM shall examine the situation as soon as possible and, at its discretion, may agree to extend the work completion period/ schedule, with or without liquidated damages for completion of supplier's contractual obligations by issuing an amendment to the work order.
- 15. **Risk Purchase Clause:** If the successful bidder fails to abide by the terms and conditions of the agreement arising out of this enquiry (or) fails to performance of services as per the work completion period/schedule or any time repudiates the contract, the purchaser will have the right to,
 - a) Render service from other agencies at the risk and cost of the successful bidders. The cost difference between the alternative arrangement and existing work order issued against ARC value where the default has been made, will be recovered from the successful bidders along with the other incidental charges.
 - b) In case of procurement through alternative sources, if procurement price is lower than the work order value wherein default has been made, in such case no benefit on this account will be passed on to the supplier.
 - c) Forfeiture of performance security.

16. Rate Contract Clause:

- a. In the Schedule of Requirement, no commitment of quantity is mentioned: only the anticipated requirement is mentioned without any commitment.
- b. BNPM reserves the right to conclude more than one rate contract for the same item.
- c. During the currency of the Rate Contract, BNPM may withdraw the rate contract by serving suitable notice. The prescribed notice period is generally thirty days.
- d. During the currency of the Rate Contract, BNPM would have the option to renegotiate the price

with the rate contract holders.

- e. During the currency of the Rate Contract, in case of emergency, BNPM may avail the same service through ad hoc contract with a new contractor.
- f. Work orders against ARC will be issued as per requirement of obtained required services.
- g. BNPM is entitled to place work orders up to the last day of the validity of the rate contract and, though services against such work orders will be affected beyond the validity period of the rate contract, all such services will be guided by the terms & conditions of the rate contract.
- h. The rate contract will be guided by "Fall Clause" as described below.

17. Fall Clause:

If the rate contract holder reduces its price or sells or even offers to sell the rate contracted services, following conditions of sale similar to those of the rate contract, at a price lower than the rate contract price, to any person or organization during the currency of the rate contract, the rate contract price will be automatically reduced with effect from that date for all the subsequent services under the rate contract and the rate contract amended accordingly. Any violation of the fall clause would be considered a serious misdemeanour under clause 44 of the GIT and action, as appropriate, would be taken as per provision of that clause.

18. **Force Majeure:** In the event of any unforeseen event directly interfering with the performance of service arising during the currency of the contract, such as war, hostilities, acts of the public enemy, civil commotion, sabotage, fires, floods, explosions, epidemics, quarantine restrictions, strikes, lockouts, or acts of God, the successful bidder shall, within a week from the commencement thereof, notify the same in writing to the Purchaser (BNPM) with reasonable evidence thereof. Unless otherwise directed by BNPM in writing, the supplier shall continue to perform its obligations under the contract as far as reasonably practical, and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event. If the force majeure condition(s) mentioned above be in force for a period of 90 days or more at any time, either party shall have the option to terminate the contract on expiry of 90 days of commencement of such force majeure by giving 14 days' notice to the other party in writing. In case of such termination, no damages shall be claimed by either party against the other, save and except those which had occurred under any other clause of this contract prior to such termination.

19. Obligations by successful bidders:

- i) All successful bidders are obliged under the CIPP (Code of integrity of public procurement) to suo moto proactively declare any conflict of interest (coming under the definition as mentioned in conflict of interest clause below, pre-existing or as and as soon as these arise at any stage) in any procurement process or execution of contract. Failure to do so would amount to violation of this Code of Integrity; and
- ii) Any successful bidder must declare, whether asked or not in a bid document, any previous transgressions of such a Code of Integrity with any entity in any country during the last 1 (One) year of being debarred by any other Procuring Entity. Failure to do so would amount to violation of this code of integrity.
- 20. **Conflict of Interest:** A successful bidder shall not have conflict of interest with other successful bidders. Such conflict of interest can lead to anti-competitive practice to the detriment of BNPM interests. The successful bidder found to have a conflict of interest shall be disqualified after giving a reasonable opportunity of being heard. A successful bidder may be considered to have a conflict of interest with one or more parties in this bidding process, if:

- a. If its personnel have a close personal, financial, or business relationship with any personnel of the procuring entity who are directly or indirectly related to the procurement or execution process of the contract, which can affect the decision of the procuring entity directly or indirectly;
- b. The successful bidder (or his allied firm as defined by DOE, MOF,GOI) provided services for the need assessment/procurement planning of the Tender process in which it is participating;
- c. A Principal can authorize only one agent, and an agent should not represent or quote on behalf of more than one Principal. However, this shall not debar more than one Authorized distributor (with/ or without the OEM) from quoting equipment manufactured by an Original Equipment Manufacturer (OEM) in procurements under Proprietary Article Certificate or
- d. A successful bidder participates in more than one bid in this tender process. - 23. The BNPMIPL reserves the right to accept the offer by individual items and reject any or all tenders without assigning any reason thereof and does not bind itself to accept lowest quotations.
- 24. Divisibility & split-ability of contract: Quantity in this tender is not divisible/not split-able.
- 25. **Settlement of Disputes through Arbitration:** All disputes and differences of any kind whatsoever arising out of or in connection with the contract, whether during the progress of the work or after their completion except accepted matters shall be settled through arbitration process as per the Arbitration & Conciliation Act, 1996. The venue of arbitration shall be Mysuru, Karnataka.
- 26. **Legal Jurisdiction:** The Courts of Mysuru (Karnataka State) shall alone have jurisdiction to decide on any legal matter of dispute whatsoever arising out or in respect of the contract.
- 27. **Rights of Rejection:** BNPMIPL reserves the right to reject any or all the applied bids without assigning any reason whatsoever. The enquiry can be rejected on national security grounds.
- 28. Preference for Micro and Small Enterprises (*MSEs): NA
- 29. **Startup** NA.
