I. NOTICE INVITING TENDER

- 7. Tenders not properly filled, mutilated with incorrect calculations or generally not complying with the conditions may be rejected.
- 8. Tenders should quote their prices and rates both in figures and in words. No blank spaces shall be left. All erasures and corrections made while filling up the tender shall be initiated by the Tenderer.
- 9. The Tender shall remain open for acceptance for a period of 60 days from the date of opening of the tender.

10. EVALUATION CRITERIA:

- (i) Techno-commercial bid / Pre Qualification bid shall be opened together and however, the Techno-commercial bid of pre-qualified bidder who meets the eligibility criteria shall be scrutinized and evaluated by the competent committee/ authority with reference to the parameters prescribed in the tender document. Subsequently, in the second stage the financial bids of only technically acceptable offers as decided in first stage shall be opened for further scrutiny and evaluation. Intimation regarding opening of financial bids shall be given to acceptable tenderers to enable them to attend the financial bid opening, if they so desire.
- (ii) If overall L1 bidder is not L1 for all individual items as mentioned in Schedule of Price, then overall L1 bidder shall be given a chance to match with L1 price of particular item where he is not L1.
- (iii) If overall L1 bidder refuses to supply the item at respective L1 rate, then Company reserve the right to split the order and procure the items from item wise L1 bidders.
- 11. Prices quoted should include GST and any other duties and taxes leviable by the Central and state governments and other statutory bodies. The rates quoted will be treated as all-inclusive and no further claims whatsoever will be entertained in this respect. The quoted rates should be FOR Mysore site basis.
- 12. The acceptance of the tender will rest with the Owner, who does not bind himself to accept the lowest tender and reserves to himself the authority to reject any or all of the tender received without assigning any reason thereof.
- 13. The owner also reserves the right to allot the order partly or wholly to single or different tenderer.

14. Discrepancy in Prices:

i) If, in the price structure quoted by a tenderer, there is discrepancy between the unit price and the total price (which is obtained by multiplying the unit price by the quantity), the unit price shall prevail and the total price corrected accordingly, unless BNPM feels that the tenderer has made a mistake in placing the decimal point in the unit price, in which case the total price as quoted shall prevail over the unit price and the unit price corrected accordingly.



ii) If, there is an error in a total price, which has been worked out through addition and/ or subtraction of subtotals, the subtotals shall prevail and the total corrected; and

iii) If, there is a discrepancy between the amount expressed in words and figures, the amount in words shall prevail

iv)If, as per the judgment of BNPM, there is any such arithmetical discrepancy in a tender, the same will be suitably conveyed to the tenderer by registered/speed post. If the tenderer does not agree to the observation of BNPM, the Tenderer is liable to be ignored.

15. Terms of Payment:

(i) 100% payment on receipt and delivery of items as per our specifications by the consignee at destination and on production of all required documents by the supplier.

Payments to suppliers shall be made by account payee cheque or through ECS only.

- 17. Delivery Period: Delivery shall be made within 3 weeks of issuing of Work order.
- **18. Delivery Terms:** It is responsible of the supplier to arrange transportation incase required on FOR destination basis. BNPMIPL requires material on FOR Mysore site office, Note Mudran Nagar, Mysore basis only.
- 17. **Delay or Non Delivery**: Time is essence of the contract and completion of delivery dates agreed to are binding on the seller. In the event the seller is not able to supply as per the delivery schedules given by BNPM, Purchaser will have right either to cancel the order without prejudice to any other rights or to make purchase from an alternate source at the risk and cost of the seller.
- 18. Liquidated Damages: The Employer/Owner shall levy a penalty at the rate of 0.5% of the delivered price of the delayed goods per week or part thereof of delay in delivery up to a maximum of 10% of the delayed items.
- 19. **Tender Evaluation and award of work**: Tender will be evaluated as per the terms and based on responsiveness taking into account all relevant factors. While the lowest offer will generally be the criteria, BNPM reserves the right to reject any offer including the lowest one if the same is not conforming to its norms. The decision of BNPM in this regard will be final.
